ORDER POSTPONING HEARING, SCHEDULING PREHEARING CONFERENCE, AND TO SHOW CAUSE AS TO ALL RESPONDENTS

On March 27, 2014, the Securities and Exchange Commission (Commission) issued an Order Instituting Proceedings (OIP) against Respondents Hendrx Corp., Plastinum Polymer Technologies Corp., Vertical Branding, Inc. (VBDG), WHY USA Financial Group, Inc. (WUFG), and XNE, Inc. (collectively, Respondents), pursuant to Section 12(j) of the Securities Exchange Act of 1934 (Exchange Act). The OIP alleges that Respondents each have a class of securities registered with the Commission pursuant to Exchange Act Section 12(g) and are delinquent in their periodic filings, in violation of Exchange Act Section 13(a) and Rules 13a-1 and 13a-13 thereunder. A hearing is scheduled to commence on April 17, 2014.

On March 31, 2014, the Division of Enforcement filed the Declaration of David S. Frye to Assist Secretary with Record of Service, which reflects that Respondents were served with the OIP by March 28, 2014, in accordance with Commission Rule of Practice 141(a)(2)(ii). See 17 C.F.R. § 201.141(a)(2)(ii). Respondents' Answers were due within ten days of service of the OIP, or by Thursday, April 10, 2014, as service was effected by mail. OIP at 3; 17 C.F.R. §§ 201.160(b), .220(b). As of today, no Respondent has filed an Answer.

Accordingly, it is ORDERED that on or before Thursday, April 24, 2014, Respondents shall SHOW CAUSE why the registrations of their securities should not be revoked by default due to their failure to file Answers or otherwise defend this proceeding. <u>See</u> 17 C.F.R. §§ 201.155(a)(2), .220(f). If any Respondent fails to respond to this Order, it shall be deemed in

default, and the proceeding will be determined against it. OIP at 3; \underline{see} 17 C.F.R. $\S~201.155(a)(2)$.

It is further ORDERED that the hearing scheduled for April 17, 2014, is postponed <u>sine</u> <u>die</u>, and a telephonic prehearing conference shall be held on Monday, May 12, 2014, at 9:30 a.m. EDT, if the proceeding has not been resolved by then.
