ORDER FOLLOWING  
PREHEARING CONFERENCE

The Securities and Exchange Commission (Commission) issued an Order Instituting Proceedings (OIP) on March 25, 2015, alleging that Winsonic Digital Media Group, Ltd. (Winsonic), has securities registered with the Commission and has not filed required periodic reports. The OIP alleges further that as of January 8, 2015, Winsonic's stock symbol WDMG was quoted on OTC Link and had six market makers. An Initial Decision is due 120 days after service of the OIP.

On April 8, 2015, I postponed the hearing and scheduled a telephonic prehearing conference for April 16, 2015. *Winsonic Digital Media Grp., Ltd.*, Admin. Proc. Rulings Release No. 2520, 2015 SEC LEXIS 1299. At the April 16, 2015, telephonic prehearing conference, Winsonic's Chief Executive Officer, Winston Johnson (Johnson), stated that Winsonic is emerging from bankruptcy, he has consulted with an auditing firm and has an appointment with a law firm, and he expects to be able file reports that have not been filed since a Form 10-Q/A was filed for the quarter ended September 30, 2008.<sup>1</sup> As a *pro se* Respondent not knowledgeable about a registrant's filing obligations, the Division of Corporation Finance, Office of Enforcement Liaison at (203) 551-3420 might be able to provide Johnson information.

As ordered at the prehearing conference, Winsonic shall file an answer by May 1, 2015, the Division of Enforcement (Division) may file a motion for summary disposition by May 22, 2015, Winsonic may file a brief in opposition by June 12, 2015, and the Division may file its reply brief by July 6, 2015. 17 C.F.R. §§ 201.220(b), .250.
