The Securities and Exchange Commission instituted this proceeding on February 13, 2015. The parties have filed motions for summary disposition and opposition papers. On May 15, I ordered that to the extent Respondents have any affirmative defenses they wish to raise – such as inability to pay monetary sanctions – their submission is due May 27, 2015. *Traci J. Anderson, CPA*, Admin. Proc. Rulings Release No. 2682, 2015 SEC LEXIS 1923. May 27 is also the due date for Respondents' reply to the Division of Enforcement's opposition to their summary disposition motion.

Today, my Office received an email from Timothy Carnahan, which included a request by Respondents for a thirty-day continuance. I construe the request as seeking a thirty-day extension of the May 27 deadline for their reply brief and presentation of affirmative defenses. There is no indication that Respondents' request was filed with the Office of the Secretary, and no certificate of service was attached.

I direct the Division to submit a response to Respondents' request by this Friday, May 22. Given the imminence of the May 27 deadline, the Division's response need not be a formal filing. If an extension is granted, it would be granted to all parties.

Respondents are reminded that any motion, brief, or request for any relief must be in writing and filed in hardcopy with the Office of the Secretary, pursuant to Rules of Practice 151 and 152. See 17 C.F.R. §§ 201.151, .152. The mailing address for filings is: Office of the Secretary, U.S. Securities and Exchange Commission, 100 F Street N.E., Mail Stop 1090, Washington, D.C. 20549. Filings must include an original and three copies. Electronic courtesy copies of filings may be sent to alj@sec.gov. However, email does not substitute for the required hardcopy filing with the Office of the Secretary.

Unless the parties agree to accept service by email, service must be made by one of the means specified in Rule of Practice 150(c). 17 C.F.R. § 201.150(c).

Any communication or paper that fails to meet these requirements may be stricken. 17 C.F.R. § 201.180(b).
