ORDER REDACTING AND PERMANENTLY
SEALING CERTAIN EXHIBITS

On October 27, 2014, the Securities and Exchange Commission issued an Order Instituting Administrative and Cease-and-Desist Proceedings (OIP) against Respondent Thrasos Tommy Petrou (Respondent), pursuant to Section 21C of the Securities Exchange Act of 1934 and Section 203(f) of the Investment Advisers Act of 1940. The hearing took place on June 8, 2015, in New York City.

On July 8, 2015, I granted in part the Motion for Protective Order filed by Respondent on July 1, 2015. *See Thrasos Tommy Petrou*, Admin. Proc. Rulings Release No. 2912, 2015 SEC LEXIS 2792. My order temporarily sealed Division Exhibits 1-3 and required Respondent to identify the portions of those exhibits he proposed be redacted. *Id.*

On July 20, 2015, Respondent filed a letter identifying his proposed redactions to Division Exhibits 1-3. The Division did not file a response. The following redactions proposed by Respondent concern sensitive personal and financial information, for which the harm resulting from the disclosure outweighs the benefits of public disclosure, *see* 17 C.F.R. § 201.322(b):

Division Exhibit 1: Responses to Questions 3, 4, 7, and 8.

Division Exhibit 2: 3:24-4:3; 23:17; 24:4-24:5; 25:20; 57:20-57:21; 57:23; 65:7-65:9; 65:11-65:12; 65:22; 96:13-96:14; 110:22.

Division Exhibit 3: 10:4; 10:7-10:9; 46:2; 47:9; 47:11; 47:15; 47:19; 47:22-47:23; 47:25.

The remainder of Respondent's proposed redactions concern information that is not sensitive personal or financial information; indeed, some of the proposed redactions concern information contained in the OIP. Accordingly, it is ORDERED that only the portions of Division Exhibits 1-3 identified above be redacted and the redacted versions of those exhibits be made public. It is FURTHER ORDERED that the unredacted versions of Division Exhibits 1-3 are PERMANENTLY SEALED and shall be disclosed only to Commissioners, employees, and agents of the Commission, and to Respondent and his counsel.
