Tier 2	\$(0.003 <u>25</u> [3])	Member has (1) an ADAV $\geq 0.25\%$ of the TCV; and (2) a Non-Displayed ADAV ≥ 4 [5],000,000 shares
Tier 3	\$(0.003 <u>1</u> [2])	Member has [(1)] an ADAV $\geq 0.20\%$ of the TCV; or (2) an ADAV $\geq 15,000,000$ shares and a Step-Up ADAV from October 2022 $\geq 0.10\%$ of the TCV]
Tier 4	\$(0.00 <u>29</u> [30])	Member has [(1)] an ADAV $\geq 0.15\%$ of the TCV; or (2) an ADAV $\geq 15,000,000$ shares]

Non-Display Add Tiers

Tier	Rebate Per Share	Required Criteria
Tier 1	\$(0.0027)	Member has a Non-Displayed ADAV $\geq 5,000,000$ shares
Tier 2	\$(0.0024)	Member has a Non-Displayed ADAV \geq <u>1,500,000</u> [2,000,000] shares
Tier 3	\$(0.00 <u>18</u> [20])	Member has a Non-Displayed ADAV \geq <u>500,000</u> [1,000,000] shares

Sub-Dollar Rebate Tier

Tier	Rebate*	Required Criteria
Tier 1	(0.15% of total dollar value)	Member has [an ADAV $\geq 0.15\%$ of the TCV; or (2)] a Sub-Dollar ADAV $\geq 5,000,000$ shares

*Rebate would apply instead of the otherwise applicable rebate for executions of added displayed volume in securities priced below \$1.00 per share. MEMX will append Fee Code “L” to the otherwise applicable Fee Code for qualifying executions.

NBBO Setter/Joiner Tiers

Tier	Additive Rebate Per Share*	Required Criteria
Tier 1	\$(0.0004)	Member has <u>(1) an ADAV with respect to orders with Fee Code B \geq 0.10% of the TCV; or (2) an ADAV with respect to orders with Fee Code B \geq 10,000,000 shares</u>
Tier 2	\$(0.0003)	Member has an ADAV \geq 0.05% of the TCV and a Displayed ADAV with respect to orders with Fee Code B or J \geq 40% of the Member’s Displayed ADAV with respect to orders with Fee Code B, D or J

*Rebate is in addition to otherwise applicable rebate for executions of added displayed volume (other than Retail Orders) in securities priced at or above \$1.00 per share that establish the NBBO or establish a new BBO on MEMX that matches the NBBO first established on an away market. MEMX will append Fee Code “S1” (for Tier 1) and “S2” (for Tier 2) to the otherwise applicable Fee Code for qualifying executions.
