The following transactions will be exempt from this Section 7, as they are deemed to neither “add” or “remove” liquidity: transactions which occur on the opening or re-opening of trading and outbound Eligible Orders sent to Away Exchanges, as these terms are defined in Chapter XII of the BOX Rules. [An exception is also made for outbound Eligible Orders sent to Away Exchanges in excess of 10,000 contracts per month, which will be charged \$0.50.] Transactions which are exempt from this Section 7 will be subject only to the applicable transaction fees listed in Sections 1 through 3 of this Fee Schedule.
