## Sec. 2 BX Options Market—Fees and Rebates

The following charges shall apply to the use of the order execution and routing services of the BX Options market for all securities.

Non-Customer	• \$0.95 per contract to any options exchange.
Customer	• Routing Fees to NOM and PHLX: \$0.05 per contract fee ("Fixed Fee") in addition to the actual transaction fee assessed.
	• Routing Fees to all other options exchanges: \$0.[11]15 per contract fee ("Fixed Fee") in addition to the actual transaction fee assessed. If the away market pays a rebate, the Routing Fee will be \$0.00.
