NOTICE THAT INITIAL DECISION HAS BECOME FINAL

The time for filing a petition for review of the initial decision in this proceeding has expired. No such petition has been filed by Calico Commerce, Inc. (a/k/a CCI Liquidation Corp.), China Fuhua New Material Holdings, Inc., China Multimedia, Inc., China Water & Drinks, Inc., or CMR Mortgage Fund II, LLC, and the Commission has not chosen to review the decision on its own initiative.

Accordingly, notice is hereby given, pursuant to Rule 360(d) of the Commission's Rules of Practice,<sup>1</sup> that the initial decision of the administrative law judge has become the final decision of the Commission with respect to Calico Commerce, Inc. (a/k/a CCI Liquidation Corp.), China Fuhua New Material Holdings, Inc., China Multimedia, Inc., China Water & Drinks, Inc., and CMR Mortgage Fund II, LLC.<sup>2</sup> The order contained in that decision is hereby declared effective. The initial decision ordered that, pursuant to Section 12(j) of the Securities
