it further appearing that this Court has jurisdiction over both defendants and the subject


matter hereof, and this Court being fully advised in the premises, and without further notice:

IT IS ORDERED, ADJUDGED AND DECREED that defendants Gene E. Phillips and Basic Capital Management, Inc. shall pay a civil penalty of \$850,000, pursuant to Section 21(d)(3) of the Securities Exchange Act of 1934 [15 U.S.C. § 78u(d)(3)], for which they shall be jointly and severally liable.

payment pursuant to Section I of this Final Judgment shall be made within 30 calendar days after the entry of this Final Judgment. Payment shall be (a) made by United States money order, certified check, bank cashier's check or bank money order, (b) made payable to the "Securities and Exchange Commission" (c) hand-delivered or mailed by certified mail (return receipt requested) to the Comptroller, Securities and Exchange Commission, Operations Center, 6432 General Green Way, Stop 0-3, Alexandria, VA 22312; and (d) submitted under cover of a transmittal letter that identifies Gene E. Phillips and Basic Capital Management, Inc. as the defendants in this action, the civil action number assigned to the Complaint, the District Court in which the Complaint, Consent and Final Judgment were filed, and the Commission's internal case number (HO-03316). The Comptroller of the Securities and Exchange Commission shall forward such funds to the proper account at the United States Treasury.
