## FINAL JUDGMENT AS TO DEFENDANT STEVEN K. GILLEY

Upon consideration of Plaintiff's motion for summary judgment against Defendant Steven K. Gilley ("Gilley" or "Defendant"), Plaintiff's motion is hereby granted and:

Ĭ.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that Defendant Gilley shall pay a civil penalty in the amount of \$5,000.00 pursuant to 15 U.S.C. §§ 77t(d) and 78u(d)(3). Defendant shall make this payment within ten (10) business days after entry of this Final Judgment by certified check, bank cashier's check, or United States postal money order payable to the Securities and Exchange Commission. The payment shall be delivered or mailed to the Office of Financial Management, Securities and Exchange Commission, Operations Center, 6432 General Green Way, Mail Stop 0-3, Alexandria, Virginia 22312, and shall be accompanied by a letter identifying Steven K. Gilley as a defendant in this action; setting forth the title and civil action number of this action and the name of this Court; and specifying that payment is made pursuant to this Final Judgment.

Defendant shall pay post-judgment interest on any delinquent amounts pursuant to 28 USC § 1961.

VI.

It Is Further Ordered, Adjudged, And Decreed that this Court shall retain jurisdiction of this matter for the purposes of enforcing the terms of this Final Judgment.
