**FINAL JUDGMENT AS TO
DEFENDANT MICHAEL
TUCHMAN**

1 The Securities and Exchange Commission having filed a Complaint and
2 Defendant Michael Tuchman having entered a general appearance; consented to
3 the Court's jurisdiction over Defendant and the subject matter of this action;
4 consented to entry of this Final Judgment without admitting or denying the
5 allegations of the Complaint (except as to jurisdiction); waived findings of fact and
6 conclusions of law; and waived any right to appeal from this Final Judgment:

7 **I.**

8 IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Defendant
9 and Defendant's agents, servants, employees, attorneys, and all persons in active
10 concert or participation with them who receive actual notice of this Final Judgment
11 by personal service or otherwise are permanently restrained and enjoined from
12 violating Section 5 of the Securities Act, 15 U.S.C. § 77e, by, directly or indirectly,
13 in the absence of any applicable exemption:

- 14 (a) Unless a registration statement is in effect as to a security, making use
15 of any means or instruments of transportation or communication in
16 interstate commerce or of the mails to sell such security through the
17 use or medium of any prospectus or otherwise;
- 18 (b) Unless a registration statement is in effect as to a security, carrying or
19 causing to be carried through the mails or in interstate commerce, by
20 any means or instruments of transportation, any such security for the
21 purpose of sale or for delivery after sale; or
- 22 (c) Making use of any means or instruments of transportation or
23 communication in interstate commerce or of the mails to offer to sell
24 or offer to buy through the use or medium of any prospectus or
25 otherwise any security, unless a registration statement has been filed
26 with the Commission as to such security, or while the registration
27 statement is the subject of a refusal order or stop order or (prior to the
28 effective date of the registration statement) any public proceeding or

1 examination under Section 8 of the Securities Act, 15 U.S.C. § 77h.

2 **II.**

3 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that
4 Defendant and Defendant's agents, servants, employees, attorneys, and all persons
5 in active concert or participation with them who receive actual notice of this Final
6 Judgment by personal service or otherwise are permanently restrained and enjoined
7 from violating Section 15(a) of the Exchange Act, 15 U.S.C. § 78o(a), by making
8 use of the mails or any means or instrumentality of interstate commerce to effect
9 any transaction, or to induce or attempt to induce the purchase or sale of, any
10 security, without being registered as a broker or dealer in accordance with Section
11 15(b) of the Exchange Act, 15 U.S.C. § 78o(b).

12 **III.**

13 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that
14 Defendant is liable for disgorgement of \$499,057, representing profits gained as a
15 result of the conduct alleged in the Complaint, together with prejudgment interest
16 thereon in the amount of \$28,105 for a total of \$527,162. Based on Defendant's
17 sworn representations in his Statement of Financial Condition dated November 19,
18 2007, and other documents and information submitted to the Commission,
19 however, the Court is not ordering Defendant to pay a civil penalty and payment of
20 all of the disgorgement and pre-judgment interest thereon is waived. The
21 determination not to impose a civil penalty and to waive payment of the
22 disgorgement and pre-judgment interest is contingent upon the accuracy and
23 completeness of Defendant's Statement of Financial Condition. If at any time
24 following the entry of this Final Judgment the Commission obtains information
25 indicating that Defendant's representations to the Commission concerning his
26 assets, income, liabilities, or net worth were fraudulent, misleading, inaccurate, or
27 incomplete in any material respect as of the time such representations were made,
28 the Commission may, at its sole discretion and without prior notice to Defendant,

1 petition the Court for an order requiring Defendant to pay the unpaid portion of the
2 disgorgement, pre-judgment and post-judgment interest thereon, and the maximum
3 civil penalty allowable under the law. In connection with any such petition, the
4 only issue shall be whether the financial information provided by Defendant was
5 fraudulent, misleading, inaccurate, or incomplete in any material respect as of the
6 time such representations were made. In its petition, the Commission may move
7 this Court to consider all available remedies, including, but not limited to, ordering
8 Defendant to pay funds or assets, directing the forfeiture of any assets, or sanctions
9 for contempt of this Final Judgment. The Commission may also request additional
10 discovery. Defendant may not, by way of defense to such petition: (1) challenge
11 the validity of the Consent or this Final Judgment; (2) contest the allegations in the
12 Complaint filed by the Commission; (3) assert that payment of disgorgement, pre-
13 judgment and post-judgment interest or a civil penalty should not be ordered; (4)
14 contest the amount of disgorgement and pre-judgment and post-judgment interest;
15 (5) contest the imposition of the maximum civil penalty allowable under the law;
16 or (6) assert any defense to liability or remedy, including, but not limited to, any
17 statute of limitations defense.

18 **IV.**

19 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the
20 Consent is incorporated herein with the same force and effect as if fully set forth
21 herein, and that Defendant shall comply with all of the undertakings and
22 agreements set forth therein.

23 **V.**


24 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that this
