**STIPULATION TO DISMISS
CLAIMS FOR MONETARY
REMEDIES AND FOR ENTRY OF
FINAL JUDGMENT AGAINST
DEFENDANT JOHN FARAHI**

1 Plaintiff Securities and Exchange Commission (“SEC”) and Defendant John
2 Farahi (“Defendant”), hereby agree and stipulate as follows:

3 WHEREAS, On February 25, 2010, Defendant consented to entry of a final
4 judgment of permanent injunction, which, among other things, ordered Defendant to
5 pay disgorgement and a civil penalty in an amount to be determined at a later date; and

6 WHEREAS, the parties agree that disgorgement, prejudgment interest, and a
7 civil penalty pursuant to Section 20(d) of the Securities Act, 15 U.S.C., § 77t(d);
8 and Section 21(d) of the Exchange Act, 15 U.S.C. § 78(d)(3), are appropriate in
9 this case; however, the SEC has determined to dismiss its claim for disgorgement,
10 prejudgment interest, and a civil penalty, and

11 WHEREAS, Defendant agrees that, in all other respects, the provisions of
12 the Consent he signed on February 25, 2010 and filed with this Court as Docket
13 No. 39 are binding and remain in effect.

14 NOW THEREFORE, IT IS STIPULATED AND AGREED that:

15 1. The SEC and Defendant stipulate to the dismissal of the SEC’s claims
16 for disgorgement and a civil penalty.

17 2. The SEC and Defendant stipulate to the entry of a Final Judgment of
18 Permanent Injunction in the form agreed to and submitted to the Court as a
19 proposed order herewith.
