**FINAL JUDGMENT AS TO DEFENDANTS DEREK LOPEZ
AND DA BIG KAHUNA, LLC**

Plaintiff Securities and Exchange Commission commenced this action by filing its Complaint against Defendants Derek Lopez, Da Big Kahuna, LLC, (the “Defendants”) and others. Defendants previously entered general appearances and consented to the Court’s jurisdiction over them and the subject matter of this action. [ECF Nos. 35, 36]. Defendants also previously consented to: permanent injunctions prohibiting violations of Sections 5 and 17(a) of the Securities Act of 1933 (“Securities Act”) [15 U.S.C. §§ 77e(a), 77e(c), and 77q(a)], and Section 10(b) and Rule 10b-5 of the Securities Exchange Act of 1934 (“Exchange Act”) [15 U.S.C. §§ 78j(b) and 17 C.F.R. §§ 240.10b-5]; a penny stock bar; the Commission’s entitlement to disgorgement and prejudgment interest, and to a civil money penalty pursuant to Section 20(d) of the Securities Act [15 U.S.C. § 77t(d)] and Section 21(d)(3) of the Exchange Act [15 U.S.C. § 78u(d)(3)]. [ECF Nos. 35, 36]. Presently before the Court is the Commission’s Consent Motion For Entry of Final Judgment [Dkt. No. 43]. The Commission’s Motion is **GRANTED**, and disgorgement and prejudgment interest is **ORDERED** as follows:

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Defendants Derek Lopez and Da Big Kahuna, LLC, are liable, jointly and severally, for disgorgement and prejudgment interest in the amount of \$72,442, representing profits gained as a result of the conduct alleged in the Complaint. Defendants' liability for disgorgement and prejudgment interest shall be reduced by any monies that Defendants are ordered to pay in connection with the parallel criminal proceeding, United States vs. Derek Lopez (a.k.a. "Da Big Kahuna"), 3:10-cr-138-K.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that this Court shall retain jurisdiction of this matter for the purposes of enforcing the terms of this Final Judgment.
