**PLAINTIFF'S NOTICE OF VOLUNTARY DISMISSAL WITH PREJUDICE  
OF ITS CLAIMS FOR CIVIL PENALTIES AGAINST  
DEFENDANTS CRAIG V. SIZER AND MIGUEL MESA**

Plaintiff Securities and Exchange Commission (“Commission”) hereby files this Notice of Voluntary Dismissal with prejudice as to its claims for civil penalties against Defendants Craig V. Sizer and Miguel Mesa (collectively, “Defendants”).

The Court previously entered against Defendants bifurcated judgments imposing permanent injunctions. *See* ECF Nos. 5 and 6. The disgorgement, including prejudgment interest, and civil penalty amounts, if any, were left to be determined by the Commission’s motion. The Commission now voluntarily dismisses its civil penalty claims against Defendants.

With the voluntary dismissal of the civil penalty claims against Defendants, the only remaining issues are briefed in Plaintiff’s Motion for Final Judgment against Defendants, which is being filed concurrently with this notice.
