("Judgment") without admitting or denying the allegations in the Complaint, except as specifically set forth in the Consent Of Thomas S. Hughes To Entry Of Judgment Of Permanent Injunction ("Consent"); no notice of hearing upon the entry of this Judgment being necessary; and this Court being fully advised:

I.

IT IS ORDERED, ADJUDGED AND DECREED that Hughes and his agents, servants, employees and attorneys, and all persons in active concert or participation with any of them, who receive actual notice of this Judgment by personal service or otherwise, and each of them, are permanently restrained and enjoined from, directly or indirectly, in connection with the purchase or sale of any security, by the use of any means or instrumentality of interstate commerce, or of the mails, or of any facility of any national securities exchange:

- A. employing any device, scheme, or artifice to defraud;
- B. making any untrue statement of a material fact or omitting to state a material fact necessary in order to make the statements made, in the light of the circumstances under which they were made, not misleading; or
- C. engaging in any act, practice, or course of business which operates or would operate as a fraud or deceit upon any person;

in violation of Section 10(b) of the Securities Exchange Act of 1934 [15 U.S.C. § 78j(b)] and Rule 10b-5 thereunder [17 C.F.R.

II.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Hughes shall provide all documents in his possession, custody or control to the Commission and disclose under oath all information with respect to his activities and the activities of others about which the Commission or its staff may inquire or request. Such production of documents and disclosure of information by Hughes shall be made upon reasonable notice in writing and without the service of a subpoena and subject only to the good faith assertion of any privileges recognizable pursuant to the provisions of Rule 501 of the Federal Rules of Evidence or the United States Constitution and amendments thereto.

III.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Hughes shall pay disgorgement, if any, plus prejudgment interest thereon, in an amount subsequently to be determined by the Court. In connection with any hearing to determine the appropriate amount of disgorgement, Hughes shall not raise as a defense that he is not liable for the payment of such disgorgement because he did not violate one or more of the provisions of the Exchange Act and rules thereunder set forth in the Judgment.

VI.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Court shall retain jurisdiction over this action for purposes of determining whether civil penalties will be assessed against Hughes pursuant to Section 21(d)(3) of the Exchange Act [15 U.S.C. § 78u(d)(3)] as appropriate. In connection with any hearing to determine the appropriate amount of civil penalties, Hughes shall

not raise as a defense that he is not liable for the payment of such civil penalties because he did not violate one or more of the provisions of the Exchange Act and rules thereunder set forth in the Judgment.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the provisions of the Consent filed concurrently with this Judgment are incorporated herein with the same force and effect as if fully set forth herein and that Hughes shall comply with his Consent.

VI.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Court shall retain jurisdiction over this action for all purposes, including to determine the liability of any remaining defendants in this action, to implement and enforce the terms of this Judgment and other orders and decrees which may be entered, to resolve the Commission's pending claims for civil penalties as appropriate, and to grant such other relief as this Court may deem necessary and iust.

VII.

There being no just reason for delay, the Clerk of the Court is hereby directed, pursuant to Rule 54(b) of the Federal Rules of Civil Procedure, to enter this Judgment.
