RE: Response to the Commission's Request for Additional Information

DATE: July 6, 2018

On December 18, 2017, The Depository Trust Company ("DTC") filed advance notice SR-DTC-2017-804 ("Advance Notice") with the U.S. Securities and Exchange Commission ("Commission") pursuant to Section 806(e)(1) of the Payment, Clearing, and Settlement Supervision Act of 2010 ("Clearing Supervision Act")¹ and Rule 19b-4(n)(1)(i) under the Securities Exchange Act of 1934,² in which DTC proposes to amend Loss Allocation Rules and make other changes. The Advance Notice was published for comment in the Federal Register on January 30, 2018.³

On April 10, 2018, the Commission required additional information from DTC pursuant to Section 806(e)(1)(D) of the Clearing Supervision Act.⁴ Consequently, pursuant to Section 806(e)(1) of the Clearing Supervision Act,⁵ the Commission's period of review of the Advance Notice was tolled and shall be 60 days from the date the information required by the Commission is received by the Commission, absent an additional information request.

On July 6, 2018, the Commission received DTC's response to the Commission's request for additional information. Accordingly, September 4, 2018 is the date by which the Commission shall notify DTC of any objection regarding the Advance Notice, unless the Commission requests further information for consideration of the Advance Notice.
