This letter is in response to your request, dated and received in this office on May 10, 2018, for consumer complaints, civil complaints, investigations, or preliminary inquiries concerning Acuta Opportunity Offshore Fund, Ltd. (formerly known as Longwood Opportunity Offshore Fund, Ltd. and Three Arch).

Based on the information you provided in your letter, we conducted a thorough search of the SEC's various systems of records, but did not locate or identify any information responsive to your request.
