• Number of WB-APP forms submitted to the commission for each fiscal year 2013 through 2017 and year to date 2018.

Please note the controlling decision on these records, as outlined in the attached April 7, 2015, correspondence regarding FOIA REQUEST NUMBER 14-00451-APPS. In addition, while you may note in the reply how many WB-APPs were submitted by serial submitters barred from the program, please do not exclude those figures from the statistics that you provide. In that letter, Assoc. General Counsel Richard Humes granted a Wall Street Journal request for these statistics pertaining to an earlier time period.

The decision on 14-00451-APPS should control how you fill this request and should provide for expedited processing.

Please waive any applicable fees. Release of the information is in the public interest because it will contribute significantly to public understanding of the efficiency and productivity of the whistleblower program authorized by public law. This information should be made available free of charge because it does not involve a complicated search for the agency and is delimited to a brief period of time.

If my request is denied in whole or part, I ask that you justify all deletions by reference to specific exemptions of the act. I will also expect you to release all segregable portions of otherwise exempt material. I, of course, reserve the right to appeal your decision to withhold any information or to deny a waiver of fees.

I would appreciate your communicating with me by email or telephone, rather than by mail.

I look forward to your determination regarding my request within 20 business days, as the statute requires.

Dear Mr. Linder:

This responds to your August 25, 2014¹ appeal of the response by the FOIA Office of the Securities and Exchange Commission ("SEC" or "Commission") to Rachel Ensign's request for certain statistics regarding the Commission's whistleblower program. On July 15, 2014, the FOIA Office informed Ms. Ensign that it had not located any records responsive to her request after a thorough search of the Commission's various systems of records. On appeal, you question how the SEC is unable to identify any responsive records. I have reviewed your appeal and it is granted, in part.

Ms. Ensign's request sought specific statistics pertaining to the number of applications for whistleblower awards received by the Commission. The SEC's Office of the Whistleblower ("OWB") maintains certain statistics, most of which are published in its annual report. The most recent report was issued on November 17, 2014, and includes statistics regarding the number of whistleblower tips received by fiscal year; the types of whistleblower allegations; the geographic origin of whistleblower tips; denials of applications for whistleblower rewards; and the total number of whistleblower awards granted. The report also provides details regarding

Of the statistics requested by Ms. Ensign, I have been advised by staff in the OWB that it has statistics responsive only to Item Nos. 1 and 2 of her request (as identified above in footnote 2). Enclosed are the statistics for the number of WB-APP forms submitted to the Commission since the passage of Dodd-Frank, and the number of WB-APP forms submitted to the Commission for fiscal years 2010 through 2014. Because OWB does not currently maintain the remaining statistics requested, I affirm the FOIA Officer's finding of no responsive records as it relates to Item Nos. 3 through 7 of Ms. Ensign's request. Please note that final orders granting or denying whistleblower award applications can be accessed on the Commission's website, http://www.sec.gov/litigation/apdocuments.shtml. For these reasons, your appeal is granted in part.

You have the right to seek judicial review of this determination by instituting an action in the United States Court for the District of Columbia or in the district where you reside or have your principal place of business.³ Voluntary mediation services as a non-exclusive alternative to litigation are also available through the National Archives and Records Administration's Office of Government Information Services ("OGIS").
