

This letter responds to your request dated and received in this office on June 8, 2018, for non-public records of consumer complaints, civil complaints, investigations, or preliminary inquiries against Stone Point Capital, LLC.

Research in our database index indicates that the subject of your request was listed in the search results in the matters of *Amherst Holdings* which opened on August 2009 and closed on December 2012; *Marsh & McLennan Companies, Inc.*, which opened December 2004 and closed July 2008. This information should not be interpreted to indicate that the subject of your request was the subject of a Commission matter. Should you require the actual records in this matter, please submit a request indicating the name of the matter and a description of the records requested.

Further, based on the information you provided in your letter, we conducted a thorough search of the SEC's various systems of records, but did not locate or identify and consumer complaints responsive to your request.

If you still have reason to believe that the SEC maintains the type of information you seek, please provide us with additional information, which could prompt another search. Otherwise, we conclude that no responsive information exists and we consider this request to be closed.

You have the right to appeal the adequacy of our search or finding of no responsive information to the SEC's General Counsel under 5 U.S.C. § 552(a)(6), 17 CFR § 200.80(d)(5)(iv). The appeal must be received within ninety (90) calendar days of the date of



this adverse decision. Your appeal must be in writing, clearly marked "Freedom of Information Act Appeal," and should identify the requested records. The appeal may include facts and authorities you consider appropriate.

Also, send a copy to the SEC Office of the General Counsel, Mail Stop 9612, or deliver it to Room 1120 at the Station Place address.
