Carson Street, Suite 200, Carson City, NV, 89701, USA. A true copy of a printout of the first page of Traqer's corporate status page from that website is attached hereto as Exhibit 1. Therefore, the Division provided this address to the Office of the Secretary and requested that the Secretary attempt service on Traqer's Delaware registered agent via U.S. Certified Mail. The Secretary mailed the OIP to Traqer's registered agent at the address referenced above via Certified Mail, Tracking No. 7013 2630 0002 2655 9278. The USPS tracking system confirms that it was delivered on October 29, 2024. See Exhibit 2 at page 1.

I declare under penalty of perjury that the foregoing is true and correct.


