PRELIMINARY DETERMINATIONS OF THE CLAIMS REVIEW STAFF
In response to the above-referenced Notice of Covered Action, the Securities and
Exchange Commission ("Commission") received whistleblower award claims from the
following : and ("Claimant 2")
. Pursuant to Section 21F of the Securities Exchange Act of 1934 (the
"Exchange Act") and Rule 21F-10 promulgated thereunder, the Claims Review Staff has
evaluated these claims in accordance with the criteria set forth in Rules 21F-1 through 21F-17.
The Claims Review Staff sets forth its Preliminary Determinations for the award claimants as
follows.

Claimant 2

The Claims Review Staff has preliminarily determined to recommend that the Commission deny an award to Claimant 2.

Claimant 2 did not provide original information that led to a successful enforcement action pursuant to Section 21F(b)(1) of the Exchange Act and Rules 21F-3(a) and 21F-4(c) thereunder, because the information Claimant 2 provided did not: (1) under Rule 21F-4(c)(1) of the Exchange Act, cause the Commission to (a) commence an examination, open or reopen an investigation, or inquire into different conduct as part of a current Commission examination or investigation, and (b) thereafter bring an action based, in whole or in part, on conduct that was the subject of Claimant 2's information, or (2) significantly contribute to the success of a Commission judicial or administrative enforcement action under Rule 21F-4(c)(2) of the Exchange Act.

Specifically, Claimant 2's information was submitted over five years after the investigation was opened and approximately one year after the Covered Action was filed. By this time, investigative staff was already aware of the information submitted by Claimant 2.

Accordingly, none of the information provided by Claimant 2 helped advance the investigation or the action. None of Claimant 2's information was used in, or had any impact on, the charges brought by the Commission in the Covered Action.
