FINAL JUDGMENT

This Court, having considered Plaintiff's Motion for Setting Defendants' Disgorgement Amounts and Imposing Civil Penalties against Defendants, hereby GRANTS the motion.

WHEREFORE, this Court orders as follows:

I.

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Defendant Leonard L. Zanello, Sr. ("Zanello") is liable for \$80,971.00, which sum consists of disgorgement of \$80,635.00, representing profits gained as a result of the conduct

in the Complaint, and prejudgment interest in the amount of \$336.00, and a civil penalty in the amount of \$50,000 pursuant to Section 20(d) of the Securities Act and Section 21(d)(3) of the Exchange Act.

II.

IT IS HEREBY FURTHER ORDERED, ADJUDGED, AND DECREED that Defendant Ihor A. Humesky ("Humesky") is liable for disgorgement in the amount of \$156,366.60, representing profits gained as a result of the conduct in the Complaint, and a civil penalty in the amount of \$50,000 pursuant to Section 20(d) of the Securities Act and Section 21(d)(3) of the Exchange Act.

III.

IT IS HEREBY FURTHER ORDERED, ADJUDGED, AND DECREED that Defendant Steven B. Rodd ("Rodd") is liable for disgorgement in the amount of \$156,366.60, representing profits gained as a result of the conduct in the Complaint, and a civil penalty in the amount of \$50,000 pursuant to Section 20(d) of the Securities Act and Section 21(d)(3) of the Exchange Act.

IV.

IT IS HEREBY FURTHER ORDERED, ADJUDGED, AND DECREED that Defendant Robert F. Broege, Jr. is liable for disgorgement in the amount of \$73,000.00, representing profits gained as a result of the conduct in the Complaint,

and a civil penalty in the amount of \$ 50,000 pursuant to Section 20(d) of the Securities Act and Section 21(d)(3) of the Exchange Act.

V.

IT IS HEREBY FURTHER ORDERED, ADJUDGED, AND DECREED that Defendants Zanello, Humesky, Rodd, and Broege shall make the payments ordered in Paragraphs I, II, III, and IV, above, within ten (10) business days after entry of this Final Judgment by certified check, bank cashier's check, or United States postal money order payable to the Securities and Exchange Commission. The payments shall be delivered or mailed to the Office of Financial Management, Securities and Exchange Commission, Operations Center, 6432 General Green Way, Mail Stop 0-3, Alexandria, Virginia 22312, and shall be accompanied by a letter identifying the Defendant as a defendant in this action; setting forth the title and civil action number of this action and the name of this Court; and specifying that payment is made pursuant to this Final Judgment. Defendants shall provide a copy of the payment to Robert K. Gordon, Securities and Exchange Commission, Atlanta Regional Office, 3475 Lenox Road, Suite 1000, Atlanta, Georgia 30326.


VI.

II.

IT IS HEREBY FURTHER ORDERED, ADJUDGED, AND DECREED that Defendant Ihor A. Humesky (“Humesky”) is liable for disgorgement in the amount of \$156,366.60, representing profits gained as a result of the conduct in the Complaint, and a civil penalty in the amount of \$50,000 pursuant to Section 20(d) of the Securities Act and Section 21(d)(3) of the Exchange Act.

III.

IT IS HEREBY FURTHER ORDERED, ADJUDGED, AND DECREED that Defendant Steven B. Rodd (“Rodd”) is liable for disgorgement in the amount of \$156,366.60, representing profits gained as a result of the conduct in the Complaint, and a civil penalty in the amount of \$50,000 pursuant to Section 20(d) of the Securities Act and Section 21(d)(3) of the Exchange Act.

IV.

IT IS HEREBY FURTHER ORDERED, ADJUDGED, AND DECREED that Defendant Robert F. Broege, Jr. is liable for disgorgement in the amount of \$73,000.00, representing profits gained as a result of the conduct in the Complaint,

and a civil penalty in the amount of \$ 50,000 pursuant to Section 20(d) of the Securities Act and Section 21(d)(3) of the Exchange Act.

V.

IT IS HEREBY FURTHER ORDERED, ADJUDGED, AND DECREED that Defendants Zanello, Humesky, Rodd, and Broege shall make the payments ordered in Paragraphs I, II, III, and IV, above, within ten (10) business days after entry of this Final Judgment by certified check, bank cashier's check, or United States postal money order payable to the Securities and Exchange Commission. The payments shall be delivered or mailed to the Office of Financial Management, Securities and Exchange Commission, Operations Center, 6432 General Green Way, Mail Stop 0-3, Alexandria, Virginia 22312, and shall be accompanied by a letter identifying the Defendant as a defendant in this action; setting forth the title and civil action number of this action and the name of this Court; and specifying that payment is made pursuant to this Final Judgment. Defendants shall provide a copy of the payment to Robert K. Gordon, Securities and Exchange Commission, Atlanta Regional Office, 3475 Lenox Road, Suite 1000, Atlanta, Georgia 30326.

VI.

IT IS HEREBY FURTHER ORDERED, ADJUDGED, AND DECREED that this Court shall retain jurisdiction of this matter for the purposes of enforcing the terms of this Order.
