FINAL JUDGMENT SETTING DISGORGEMENT AND IMPOSING CIVIL PENALTY AGAINST DEFENDANT JOHN DELPRINCE

THIS MATTER is before the Court on the Plaintiff's Motion To Enter Final Judgment Setting Disgorgement And Penalty Against John DelPrince and Dismiss Disgorgement And Penalty Claims Against Old Dominion Securities (D.E. # ____). The Court has reviewed the motion and the evidence submitted in support of the motion, as well as the entire record in the case, and finds that the evidence supports entry of this Final Judgment Setting Disgorgement and Imposing Civil Penalty Against Defendant John DelPrince ("Final Judgment"). Accordingly, it is

ORDERED AND ADJUDGED that the Plaintiff's motion is GRANTED. It is

FURTHER ORDERED AND ADJUDGED that Final Judgment is entered against Defendant John DelPrince in the amount of \$125,043.77. This amount represents disgorgement of \$57,411.81, prejudgment interest of \$10,220.96, and a civil penalty of \$57,411. It is

FURTHER ORDERED AND ADJUDGED that DelPrince shall pay the amount of the Final Judgment within thirty (30) days of entry of this Final Judgment to the United States Department of the Treasury, c/o Comptroller, Securities and Exchange Commission, 450 Fifth Street N.W., Washington, D.C., 20549, by cashier's check, certified check, or postal money order, under cover of a letter that identifies the name and number of this action and the name of this Court, with a copy to Robert K. Levenson, Esq., Securities and Exchange Commission, 1801 Brickell Avenue, Suite 1800, Miami, Florida, 33131, counsel of record for the Plaintiff Securities and Exchange Commission. It is

FURTHER ORDERED AND ADJUDGED that the Commission's civil penalty and disgorgement claims against Defendant Old Dominion Securities are dismissed. It is

FURTHER ORDERED AND ADJUDGED that this Court shall retain jurisdiction of this action for all purposes, including the implementation and enforcement of this Final Judgment.
