FINAL JUDGMENT
AS TO DEFENDANT
DAVID C.
KIRKPATRICK

The Securities and Exchange Commission having filed a Complaint and Defendant David C. Kirkpatrick ("Kirkpatrick") having entered a general appearance; consented to the Court's jurisdiction over him and the subject matter of this action; consented to entry of this Final Judgment without admitting or denying the allegations of the Complaint (except as to jurisdiction); waived findings of fact and conclusions of law; and waived any right to appeal from this Final Judgment:

I.

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Kirkpatrick shall pay a civil penalty in the amount of \$25,000 pursuant to the Second Claim for Relief and Section 21(d) (3) (A) of the Securities Exchange Act of 1934 [15 U.S.C. § 78u(d) (3) (A)]. Kirkpatrick shall make this payment within thirty (30) business days after entry of this Final Judgment by certified check, bank

cashier's check, or United States postal money order payable to the Securities and Exchange Commission. The payment shall be delivered or mailed to the Office of Financial Management, Securities and Exchange Commission, Operations Center, 6432 General Green Way, Mail Stop 0-3, Alexandria, Virginia 22312, and shall be accompanied by a letter identifying Kirkpatrick as a defendant in this action; setting forth the title and civil action number of this action and the name of this Court; and specifying that payment is made pursuant to this Final Judgment. A copy of the check and letter shall be simultaneously transmitted to Reid A. Muoio, Branch Chief, Securities and Exchange Commission, 100 F Street, N.E., Washington, DC 20549-6030, Tel: 202/551-4488, Fax: 202/772-9346.

II.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the Consent is incorporated herein with the same force and effect as if fully set forth herein, and that Kirkpatrick shall comply with all of the undertakings and agreements set forth therein.

III.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the First, Third, Fourth and Fifth Claims for Relief are dismissed with prejudice.


IV.
