## AGREED FINAL JUDGMENT AGAINST DEFENDANTS BMA VENTURES, INC. AND WILLIAM ROBERT KEPLER

The Securities and Exchange Commission having filed a Complaint and Defendants BMA Ventures, Inc., and William Robert Kepler ("Defendants") having entered a general appearance; consented to the Court's jurisdiction over them and the subject matter of this action and having agreed to voluntarily withdraw the registration as an investment advisor; consented to entry of this Final Judgment without admitting or denying the allegations of the Complaint (except as to jurisdiction); waived findings of fact and conclusions of law; and waived any right to appeal from this Final Judgment:

I.

It is HEREBY Ordered, Adjudged, And Decreed that Defendant BMA Ventures, Inc., shall, within thirty days of the entry of this Final Judgment, cause to be filed with the Commission a Form ADV-W withdrawing its registration as an investment adviser. It is further ORDERED that Defendant Kepler shall take all actions necessary to cause BMA Ventures, Inc., to file a Form ADV-W with the Commission, within thirty days of the entry of this Final

Judgment, and cause the entity to withdraw its registration as an investment adviser with the Commission.

II.

It Is Further Ordered, Adjudged, And Decreed that the Consent of each Defendant is incorporated herein with the same force and effect as if fully set forth herein, and that Defendants shall comply with all of the undertakings and agreements set forth therein.

III.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that all other relief requested that is not granted herein is denied.

IV.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that this Court shall retain jurisdiction of this matter for the purposes of enforcing the terms of this Final Judgment.
