I.

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Defendant and Defendant's agents, servants, employees, attorneys, and all persons in active concert or participation with them who receive actual notice of this Final Judgment by personal service or otherwise are permanently restrained and enjoined from violating Section 17(a)(2) of the Securities Act of 1933 (the "Securities Act"), 15 U.S.C. § 77q(a)(2), in the offer or sale of any security by the use of any means or instruments of transportation or communication in interstate commerce or by use of the mails, directly or indirectly, by obtaining money or property by means of any untrue statement of a material fact or any omission of a material fact necessary in order to make the statements made, in light of the circumstances under which they were made, not misleading.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that Defendant shall pay a civil penalty in the amount of \$25,000 pursuant to Section 20(d) of the Securities Act, 15 U.S.C. § 77t(d). Defendant shall make this payment within 14 days after entry of this Final Judgment by certified check, bank cashier's check, or United States postal money order payable to the Securities and Exchange Commission. The payment shall be delivered or mailed to the Office of Financial Management, Securities and Exchange Commission, Operations Center, 6432 General Green Way, Mail Stop 0-3, Alexandria, Virginia 22312, and shall be accompanied by a letter identifying Edward P. Ryan as a defendant in this action; setting forth the title and civil action number of this action and the name of this Court; and specifying that payment is made pursuant to this Final Judgment. Defendant shall pay post-judgment interest on any delinquent amounts

1	pursuant to 28 U.S.C. § 1961. The Commission shall remit the funds paid pursuant to this
2	paragraph to the United States Treasury.

4	IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the Consent of
5	Defendant Edward P. Ryan is incorporated herein with the same force and effect as if fully set
6	forth herein, and that Defendant shall comply with all of the undertakings and agreements set
7	forth therein.
8	IV.
9	IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that this Court shall retain
10	jurisdiction of this matter for the purposes of enforcing the terms of this Final Judgment.

12	There being no just reason for delay, pursuant to Rule 54(b) of the Federal Rules of Civil
13	Procedure, the Clerk is ordered to enter this Final Judgment forthwith and without further notice.
