I.

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Defendant Zeglis, as Executor is liable for disgorgement of \$25,000, representing profits gained by the estate as a result of the conduct alleged in the Complaint, together with prejudgment interest thereon in the amount of \$5,254.67, for a total of \$30,254.67. Defendant Zeglis, as Executor shall satisfy this obligation by paying \$30,254.67 within thirty (30) business days after entry of this Final

Judgment by certified check, bank cashier's check, or United States postal money order payable to the Securities and Exchange Commission. The payment shall be delivered or mailed to the Office of Financial Management, Securities and Exchange Commission, Operations Center, 6432 General Green Way, Mail Stop 0-3, Alexandria, Virginia 22312, and shall be accompanied by a letter identifying John Zeglis, as Executor, Successor/Representative to the Estate of James D. Zeglis, as a defendant in this action; setting forth the title and civil action number of this action and the name of this Court; and specifying that payment is made pursuant to this Final Judgment. Defendant Zeglis, as Executor shall pay post-judgment interest on any delinquent amounts pursuant to 28 USC § 1961. The Commission shall remit the funds paid pursuant to this paragraph to the United States Treasury. Defendant Zeglis, as Executor shall simultaneously transmit photocopies of such payment and letter to the Edward G. Sullivan, Esq., Securities and Exchange Commission, 3475 Lenox Road, N.E. Suite 1000, Atlanta, Georgia 30326. By making this payment. Defendant Zeglis, as Executor relinquishes all legal and equitable right, title, and interest in such funds, and no part of the funds shall be returned to Defendant Zeglis, as Executor.

H.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the Consent is incorporated herein with the same force and effect as if fully set forth herein, and that Defendant Zeglis, as Executor shall comply with all of the undertakings and agreements set forth therein.

III.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that this Court shall retain jurisdiction of this matter for the purposes of enforcing the terms of this Final Judgment.
