**FINAL JUDGMENT AGAINST  
DEFENDANT FARZIN  
BAZSHUSHTARI**

19 The Securities and Exchange Commission having filed a Complaint and  
20 Defendant Farzin Bazshushtari (“Defendant”) having entered a general appearance,  
21 consented to the Court’s jurisdiction over him and the subject matter of this action,  
22 consented to entry of this Final Judgment without admitting or denying the  
23 allegations of the Complaint (except as to jurisdiction), waived findings of fact and  
24 conclusions of law, and waived any right to appeal from this Final Judgment:

25 **I.**

26 IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Defendant  
27 and Defendant’s agents, servants, employees, attorneys, and all persons in active  
28 concert or participation with them who receive actual notice of this Final Judgment

1 by personal service or otherwise are permanently restrained and enjoined from  
2 violating, directly or indirectly, Section 10(b) of the Securities Exchange Act of  
3 1934 (the "Exchange Act"), 15 U.S.C. § 78j(b), and Rule 10b-5 promulgated  
4 thereunder, 17 C.F.R. § 240.10b-5, by using any means or instrumentality of  
5 interstate commerce, or of the mails, or of any facility of any national securities  
6 exchange, in connection with the purchase or sale of any security:

- 7 (a) to employ any device, scheme, or artifice to defraud;
- 8 (b) to make any untrue statement of a material fact or to omit to state a  
9 material fact necessary in order to make the statements made, in the  
10 light of the circumstances under which they were made, not  
11 misleading; or
- 12 (c) to engage in any act, practice, or course of business which operates or  
13 would operate as a fraud or deceit upon any person.

14 **II.**

15 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that  
16 Defendant is liable for disgorgement of \$76,676.50, representing profits gained as  
17 a result of the conduct alleged in the Complaint, together with prejudgment interest  
18 thereon in the amount of \$7089.87, and a civil penalty in the amount of \$76,676.50  
19 pursuant to 15 U.S.C. § 78u-1(a)(2). Defendant shall satisfy this obligation by  
20 paying \$160,442.87 within 14 days after entry of this Final Judgment by certified  
21 check, bank cashier's check, or United States postal money order payable to the  
22 Securities and Exchange Commission. The payment shall be delivered or mailed  
23 to the Office of Financial Management, Securities and Exchange Commission, 100  
24 F Street, NE, Stop 6042, Washington DC 20549, and shall be accompanied by a  
25 letter identifying Farzin Bazshushtari as a defendant in this action, setting forth the  
26 title and civil action number of this action and the name of this Court, and  
27 specifying that payment is made pursuant to this Final Judgment. A copy of the  
28 cover letter and check or money order shall be sent to Karen Matteson, Esq., Los

1 Angeles Regional Office, United States Securities and Exchange Commission,  
2 5670 Wilshire Boulevard, 11<sup>th</sup> Floor, Los Angeles, California 90036. Defendant  
3 shall pay post-judgment interest on any delinquent amount pursuant to 28 U.S.C. §  
4 1961. The Commission shall remit the funds paid pursuant to this paragraph to the  
5 United States Treasury.

6 **III.**

7 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that  
8 Defendant's Consent is incorporated herein with the same force and effect as if  
9 fully set forth herein, and that Defendant shall comply with all of the undertakings  
10 and agreements set forth therein.

11 **IV.**

12 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that this  
13 Court shall retain jurisdiction of this matter for the purpose of enforcing the terms  
14 of this Final Judgment.

15 **V.**

16 There being no just reason for delay, pursuant to Rule 54(b) of the Federal  
17 Rules of Civil Procedure, the Clerk is ordered to enter this Final Judgment  
18 forthwith and without further notice.
