**PLAINTIFF'S NOTICE OF VOLUNTARY DISMISSAL OF ITS CLAIMS FOR
DISGORGEMENT, PREJUDGMENT INTEREST AND CIVIL PENALTY AGAINST
DEFENDANTS INNOVIDA HOLDINGS, LLC AND CLAUDIO OSORIO**

Plaintiff Securities and Exchange Commission files this Notice of Voluntary Dismissal as to its claims for disgorgement, prejudgment interest and civil penalties against Defendants InnoVida Holdings LLC and Claudio Osorio.

The Court previously entered permanent injunctions and other relief against Osorio and InnoVida. The Commission now voluntarily dismisses its disgorgement, prejudgment interest and civil penalty claim against InnoVida because InnoVida is in bankruptcy, and its disgorgement, prejudgment interest and civil penalty claim against Osorio because of, among other things, sanctions in the parallel criminal case.

This will resolve all issues as to InnoVida and Osorio. Simultaneously with this notice, the Commission is filing papers asking the Court to enter a judgment against Defendant Craig Toll that will resolve this case in its entirety.
