**ORDER GRANTING PLAINTIFF'S MOTION TO SET CIVIL
PENALTY AMOUNT AS TO DEFENDANT RYAN F. COBLIN**

THIS CAUSE comes before the Court on Plaintiff Securities and Exchange Commission's Motion and Memorandum of Law to Set Civil Penalty as to Defendant Ryan F. Coblin [**DE 26**] filed on November 8, 2013. The Court previously entered a Judgment of Permanent Injunction and Other Relief as to Defendant Ryan F. Coblin. *See* [**DE 20**]. The Judgment of Permanent Injunction provides the Court shall determine the amount of the civil penalty upon the Commission's motion pursuant to Section 20(d) of the Securities Act of 1933 (the "Securities Act") [15 U.S.C. § 77t(d)] and Section 21(d)(3) of the Securities Exchange Act of 1934 (the "Exchange Act") [15 U.S.C. § 78u(d)(3)].

The Court has carefully considered the motion, applicable law, and pertinent portions of the record. It is hereby

ORDERED AND ADJUDGED that the Commission's Motion [**DE 26**] is **GRANTED**.

IT IS FURTHER ORDERED AND ADJUDGED that Defendant Coblin is liable for a civil penalty in the amount of **\$12,500**, pursuant to Section 20(d) of the Securities Act, 15 U.S.C. § 77t(d) and Section 21(d)(3) of the Exchange Act of 1934, 15 U.S.C. § 78u(d)(3). The total amount, \$12,500, shall be due and payable within 14 days after entry of this Final Judgment.

Defendant Coblin may transmit payment electronically to the Commission, which will provide detailed ACH transfer/Fedwire instructions upon request. Payment may also be made directly from a bank account via Pay.gov through the SEC website at <http://www.sec.gov/about/offices/ofm.htm>. Defendant Coblin may also pay by certified check, bank cashier's check, or United States postal money order payable to the Securities and Exchange Commission, which shall be delivered or mailed to

and shall be accompanied by a letter identifying the case title, civil action number, and name of this Court; Ryan F. Coblin as a defendant in this action; and specifying that payment is made pursuant to this Final Judgment.

Defendant Coblin shall simultaneously transmit photocopies of evidence of payment and case identifying information to the Commission's counsel in this action. By making this payment, Defendant Coblin relinquishes all legal and equitable right, title, and interest in such funds and no part of the funds shall be returned to Defendant. The Commission shall send the funds paid pursuant to this Final Judgment to the United States Treasury.

IT IS FURTHER ORDERED AND ADJUDGED that this Court shall retain jurisdiction over this matter and Defendant Coblin in order to implement and carry out the terms

of this Judgment and all Orders and Decrees that may be entered, and/or to entertain any suitable application or motion for additional relief within the jurisdiction of this Court
