ORDER IMPOSING CIVIL PENALTY AS TO DEFENDANT SLICHENMYER

Plaintiff, Securities and Exchange Commission (“Commission”) having filed a Complaint in this action on March 29, 2016; defendant William Slichenmyer having consented on October 25, 2017 to entry of a final judgment as to him; a Final Judgment having been entered as to Slichenmyer on February 9, 2018; and the Court having considered the parties’ written submissions and oral arguments on the Commission’s motion for imposition of a civil penalty and an order barring Slichenmyer from acting as an officer or director of a public company:

IT IS ORDERED, ADJUDGED, AND DECREED that Slichenmyer shall pay a civil penalty in the amount of \$50,000 to the Securities and Exchange Commission pursuant to Section 20(d) of the Securities Act [15 U.S.C. § 77t(d)] and Section 21(d)(3) of the Exchange Act [15 U.S.C. § 78u(d)(3)]. Slichenmyer shall make this payment within 14 days after entry of this Order.

Slichenmyer may transmit payment electronically to the Commission, which will provide detailed ACH transfer/Fedwire instructions upon request. Payment may also be made directly from a bank account via Pay.gov through the SEC website at <http://www.sec.gov/about/offices/ofm.htm>. Slichenmyer may also pay by certified check, bank cashier's check, or United States postal money order payable to the Securities and Exchange Commission, which shall be delivered or mailed to

and shall be accompanied by a letter identifying the case title, civil action number, and name of this Court; Slichenmyer as a defendant in this action; and specifying that payment is made pursuant to this Order and the Final Judgment.

Slichenmyer shall simultaneously transmit photocopies of evidence of payment and case identifying information to the Commission's counsel in this action. By making this payment, Slichenmyer relinquishes all legal and equitable right, title, and interest in such funds and no part of the funds shall be returned to Slichenmyer. The Commission shall send the funds paid pursuant to this Order and Final Judgment to the United States

Treasury. Defendant shall pay post-judgment interest on any delinquent amounts pursuant to 28 USC § 1961.
