Mrs. Chandler reports directly to Mark T. Finn, Vantage's CEO, and is supervised by him on a continuous basis. Mrs. Chander serves as Vantage's President and as a portfolio manager for several institutional clients. The portfolio managers meet regularly and as needed with the CEO to determine the appropriate investment advice to be given to the clients. Supervision includes regular communication and meetings to follow up on investment actions, review of client reports and follow up communications with clients and other managers/service providers to accounts. The firm's CEO has access to client reports which are reviewed regularly. All personal trading is required to be reported to the CEO at least quarterly, or more often if neccessaary in accordance with the firm's policies and procedures. Vantage has adopted policies and procedures and a compliance program designed to prevent, detect and correct actual or potential violations by the adviser and its supervised persons. Vantage conducts and annual review to access the firm's business, policies, procedures and personnel activity.
