AAG Insurance Agency, Inc. holds life, accident, health and variable contract agency licenses in several states. In addition to being registered with GAA as an Investment Advisor Representative, Peter Nerone is an officer and Registered Representative of the broker-dealer and serves as the insurance-licensed officer for all insurance agency licenses held by GAA or AAG Insurance Agency, Inc. Peter Nerone is a salaried employee of Great American Financial Resources, Inc. ("GAFRI"). GAFRI is the parent company of both GAA and AAG Insurance Agency, Inc. GAA maintains registration as a broker-dealer and manages the insurance agency licenses of both GAA and AAG Insurance Agency, Inc. for the sole purpose of providing support for variable annuity distribution through GAFRI. GAA does not maintain retail brokerage accounts and Peter Nerone does not receive commissions, bonuses or other compensation based on the sale of securities or other investment products.

Peter Nerone does not receive any additional compensation including sales awards, other prizes or bonuses based upon number or amount of sales, client referrals, or new accounts.
