Item 2 - Educational Background and Business Experience

Mr. Bransky was born in 1968. He serves as a Financial Advisor for Ziegler Wealth Management's (ZWM) Chicago, Illinois location. He earned a Bachelor of Arts in Economics from Tulane University in New Orleans, Louisiana. Andrew joined ZWM in 2007 as a Financial Advisor. Prior to joining ZWM he was a Financial Advisor with Wachovia Securities, LLC for 12 years. Prior to Andrew's time with Wachovia before becoming a Financial Advisor, he was a professional Floor Trader at the Chicago Mercantile Exchange for four years. During his time as a Floor Trader, he began a number of parallel businesses; he created a daily trading advisory service and formed a business teaching trading risk/reward management.

In 2009, Mr. Bransky was the subject of an investment-related, consumer-initiated, written complaint, which alleged he was involved sales practice violations. The matter involved bonds that were sold to the client in a private placement transaction. The matter is still pending.
