The matter involved allegations of misrepresentation and unsuitable investment recommendations resulting in compensatory damages of \$50,000. Merrill Lynch settled the matter with the customer for \$20,000.

## **Item 5 - Additional Compensation**

Mr. Chandiwala may receive compensation in the form of commissions from the sale of investments in his capacity as a registered representative.
