## **Item 2 - Educational Background and Business Experience**

Mr. Steinke was born in 1959. He serves as a Financial Advisor for Ziegler Wealth Management's (ZWM) Waukesha, Wisconsin location. Mr. Steinke has 29 years of experience in the financial services industry and has been with Ziegler for his entire career. Mr. Steinke has been a member of the adjunct teaching faculty at the Lubar School of Business at University of Wisconsin in Milwaukee, Wisconsin (UWM) since 2005 where he teaches courses in finance and economics. Mr Steinke joined ZWM in 1989 and holds the position of Vice President, Financial Advisor.

## **Item 3 - Disciplinary Information**

In 2010, Mr. Steinke was the subject of an investment-related, consumer-initiated, written complaint, which alleged he was involved in sales practice violations. The matter involves allegations of misrepresentation of certain bonds resulting in compensatory damages of \$649,016. The matter was resolved via FINRA arbitration with an award going to the customer of \$175,254.

## **Item 4 - Other Business Activities**

Mr. Steinke is actively engaged in other business activities. He currently is a college instructor teaching finance and economics at the University of Wisconsin and spends approximately 5% of his time on this activity. Mr. Steinke is compensated approximately \$10,000 annually for this other business activity.

## **Item 5 - Additional Compensation**

Mr. Steinke may receive compensation in the form of commissions from the sale of investments in his capacity as a registered representative. Mr. Steinke may also receive compensation from insurance sales. Mr. Steinke does not receive any additional economic benefit from third parties for providing advisory services other than noted above.
