Joshua Welch is not a supervising authority at Steven Welch, CPA but does work closely with and is monitored by the supervising member of the firm. The supervising member is Steven Welch; who remains aware of and keeps us in compliance with the current rules and regulations put forth by each ruling regulatory authority where we conduct our business. Steven Welch, CPA has established internal policies for the guidance of its trading personnel, specifying minimum and maximum commissions to be paid for various types and sizes of transactions. Transactions, which vary from the guidelines, are subject to periodic supervisory review. These guidelines are reviewed yearly and periodically adjusted. The general level of brokerage commissions paid is periodically reviewed by Steven Welch, CPA. Evaluations of the reasonableness of brokerage commissions are made by Steven Welch, CPA's trading personnel while effecting portfolio transactions for clients.

Steven Welch, CPA maintains and periodically updates a list of approved brokers and dealers, which is generally capable of providing best price and execution and is financially stable. Steven Welch, CPA's traders are directed to use only brokers and dealers on the approved list, except in the case of client designations of brokers or dealers to effect transactions for such clients' accounts.
