## Item 2 – Educational Background and Business Experience

Registered investment advisers are required to disclose in this Item the supervised person's name, year of birth, educational background, and business background. Following is the information responsive to this requirement:

Name of Supervised Person: Zaheer Edoo

Year of Birth: 1973

Formal Education: Mr. Edoo earned his Bachelor of Arts in Economics (Honours) from McGill University in Montreal, Canada, and his Masters of Business Administration from Georgetown University in Washington, D.C. In 2003, he earned the Chartered Financial Analyst ("CFA") designation from the CFA Institute. Note that in order to qualify as a CFA candidate, the candidate must meet one of the following requirements: (1) undergraduate degree and four years of professional experience involving investment decision-making, or (2) four years qualified work experience (full time, but not necessarily investment related). In order to earn the CFA designation, the candidate must successfully complete three levels. Each level requires approximately 250 hours of study and culminates in a six-hour exam. Completing the program takes most candidates between three and five years.

Business Experience: Mr. Edoo has held the position of Managing Director and Chief Executive Officer of Vega Capital since the Firm's business inception in March of 2003, where he focuses on managing the investment portfolios of high net worth individuals. He is also the majority owner of Vega Capital. From December of 2008 to April of 2009, Mr. Edoo was employed by Beta Capital Management L.P. ("Beta Capital") as a research analyst. From 2003 to 2008, Mr. Edoo was an Investment Manager for Wise Holdings Limited, managing the investment portfolio and real estate portfolio for this private investment company. From July of 2002 to March of 2003, he was an Investment Manager for RBTT Trust Limited. From August of 2000 to August of 2001, Mr. Edoo was employed by Deloitte & Touche LLP as a Senior Consultant in the Valuation Group for Financial Advisory Services.

## Item 3 – Disciplinary Information

## Item 4 – Other Business Activities

Mr. Edoo is not actively engaged in any other investment-related business or occupation. Mr. Edoo may, however, receive commission revenue generated from trades executed through West Indies Stockbrokers Ltd., a Trinidad-based broker/dealer. Mr. Edoo does not otherwise receive any commissions, bonuses or other cash or non-cash compensation based on the sale of securities or other investment products. Additionally, Mr. Edoo is not actively engaged in any noninvestment-related business or occupation that represents a substantial source of his income or involves a substantial amount of his time.

### **Item 5 – Additional Compensation**

Mr. Edoo is the majority owner of Vega Capital. As the majority owner, Mr. Edoo may receive distributions and profits from Vega Capital beyond a regular salary. Mr. Edoo does not receive any compensation or additional economic benefits from any third party for providing advisory services through Vega Capital.

### **Item 6 – Supervision**

Mr. Edoo serves as the Managing Director, Chief Executive Officer, and Chief Compliance Officer of the Firm. There is no person at the Firm senior to Mr. Edoo. Mr. Edoo's telephone number is 786-216-7547. Ultimately, Mr. Edoo is responsible for supervision of the individuals providing investment advice to clients. Given the small number of clients and employees at the Firm, supervision is performed on an individual client basis.
