3.D. Other Business Activities

Mr. Harter is an associated person with Forefront Capital Markets LLC ("FCM"), a FINRA Member Firm, an SEC-registered broker-dealer, and a member of SIPC. FCM is a financial services company engaged in the sale of investment products. Approximately 80% of his time and effort is attributable to the functions of Pactolus, while the remaining 20% of his time is allocated to the function of merchant bank commission sales as a registered representative of FCM. Mr. Harter generally receives asset based fees from investment advisory clients. In certain instances with respect to merchant banking activities, Mr. Harter receives commission based compensation. Such compensation is immaterial to his overall compensation as an investment advisory representative.

3.E. Additional Compensation

Other than advisory fees charged to his clients and commission revenue derived from merchant banking activities, Mr. Harter does not receive additional compensation.
