***Item 2 – Educational Background and Business Experience***

From 2005 to 2012 he was a principal partner/owner in multiple residential and commercial real estate developments. During this time he planned and executed all aspects of a typical real estate development; from investor relations to property acquisition to development. He joined CoreStates Realty Group, LLC (“CRG”) in 2012 and is Vice President of Acquisitions.
