Receipt of this compensation creates a conflict of interest as Mr. Rosenberg may have an incentive to recommend investment products based on the compensation received, rather than on the client's needs. All investment adviser representatives of the firm have a fiduciary duty to act in the best interest of the firm's clients.

Mr. Rosenberg does not receive additional compensation that is based, all or in part, on the number or amount of sales, client referrals, or new accounts. He does not receive economic benefit from anyone who is not a client to whom he is providing advisory services.
