The CIMA certification signifies that an individual has met initial and on-going experience, ethical, education, and examination requirements for investment management consulting, including advanced investment management theory and application. To obtain the CIMA certification, candidates must pass an online Qualification Examination, successfully complete a one-week classroom education program provided by a Registered Education Provider at an AACSB accredited university business school, and pass an online Certification Examination. CIMA designees are required to adhere to IMCA's Code of Professional Responsibility, Standards of Practice, and Rules and Guidelines for Use of the Marks. CIMA designees must report 40 hours of continuing education credits, including two ethics hours, every two years to maintain the certification. The designation is administered through Investment Management Consultants Association (IMCA).

1. Marshall G. Eichenauer, Jr. is also engaged in the following investment-related activities:

- President, Sagent Private Investment Fund I, LLC (SPIF)

Sagent Private Investment Fund is a non-public investment fund which holds, along with other investment assets, a 20% interest in Sagent Wealth Management (SWM).

Mr. Eichenauer's work with SPIF creates potential for a conflict of interest with his dedication to Sagent Wealth Management. This potential conflict is addressed in two ways; first through the alignment of the interests of SWM and SPIF. Because of SPIF's ownership stake in SWM, the benefit to both Mr. Eichenauer and our clients is maximized through the growth and overall success of both entities working together. The second way is through an annual audit of SPIF's operations by an independent accounting firm.

Mr. Eichenauer is compensated for his work with SPIF through a management fee assessed as a percentage of assets under management.
