Registered Representative of a Broker-Dealer

Harry ("Bud") T. Kaplan is a registered representative of LPL Financial ("*LPL Financial*"), an SEC registered broker-dealer and member of FINRA. In this capacity, Harry ("Bud") T. Kaplan may provide securities brokerage services and implement securities transactions under a commission based arrangement. Harry ("Bud") T. Kaplan may be entitled to a portion of the brokerage commissions paid to *LPL Financial*, as well as a share of any ongoing distribution or service ("trail") fees from the sale of mutual funds.

A conflict of interest exists to the extent that Harry ("Bud") T. Kaplan recommends the purchase of securities where he receives commissions or other additional compensation as a result. This practice may give him an incentive to recommend investment products based on compensation received rather than on the client's needs. Kaplan Wealth Management has procedures in place to ensure that all recommendations are made in the best interests of clients regardless of any additional compensation

earned. For certain accounts covered by ERISA (and such others that the firm deems appropriate), Kaplan Wealth Management provides investment advisory services on a fee offset basis, whereby the firm reduces its fee by an amount equal to the aggregate commissions and 12b-1 fees earned by Harry ("Bud") T. Kaplan in his individual capacity as a registered representative of *LPL Financial*.

Licensed Insurance Agent

Harry ("Bud") T. Kaplan is a licensed insurance agent and in such capacity may recommend, on a fully-disclosed commission basis, the purchase of certain insurance products. A conflict of interest exists to the extent that Kaplan Wealth Management recommends the purchase of insurance products where Harry ("Bud") T. Kaplan receives insurance commissions or other additional compensation. Kaplan Wealth Management seeks to ensure that all recommendations are made in the best interests of clients regardless of any additional compensation earned.

Kaplan Wealth Management periodically reviews the advisory activities of Harry ("Bud") T. Kaplan, which may include reviewing individual client accounts and correspondence (including e-mails) sent and received by Harry ("Bud") T. Kaplan.
