Non-discretionary bond clients receive monthly reports and discretionary accounts receive monthly or quarterly reports as per request. Reports fully describe all securities including coupon, maturity, yield and current market values.

Mutual fund clients receive transaction and current market information directly from each respective fund. They also receive a quarterly analysis, including performance, on each fund and a cumulative analysis and performance on all of the clients' mutual fund holds from Sentry Management.

8. Organization and Cross References. Except for the cover page requirements in Item 7(a) above, information contained in the brochure need not follow the order of the items listed in Item 7. However, the brochure should not be organized in such a manner that important information called by the form is obscured.
