Disciplinary Information

Form ADV Part 2B, Item 3

No one at Excalibur Management Corporation, including Wayne D. Other Business Activities

Wetzel, Jr has been retained as a consultant to Daniel J. Flynn, III and serves on an Investment Advisory Committee to the Daniel J. Flynn & Co., Inc. sponsored alternative investments in real estate. However, for Mr. Wetzel that activity does not conflict with Excalibur's business and does not provide a substantial source of income or involve a substantial amount of time.

Additional Compensation

Form ADV Part 2B, Item 5

The SEC requires that all supervised persons listed on a firm's ADV Part 2 must disclose any additional compensation they receive. As previously disclosed Wayne D. Wetzel, Jr. is a consultant and serves on an Investment Advisory Committee to the Daniel J. Flynn & Co., Inc. sponsored alternative investments in real estate and receives compensation for this service, which is not a substantial source of Mr. Wetzel's total income.

Supervision

Form ADV Part 2B, Item 6

Each supervised person is part of team of investment advisors that meets regularly to discuss investment and client related topics. The investment advice of each team member is monitored and shared with other team members on regular basis. Michael W. Delduchetto, President, 617-916-9669 supervises the advisory activity of all Excalibur Management Corporation employees.
