Item 4: Other Business Activities

Glenn Steve Goodstein is an Investment Advisor Representative of GSG Capital Advisors, LLC and an Investment Advisor Representative of Carmel Capital Partners, LLC. Neither advisory is affiliated with The Investment House, LLC. While Mr.

Goodstein devotes as much time to the business and affairs of TIH as is necessary to perform his duties as an investment adviser representative, he devotes the a portion of his time (approximately 90%) performing services for GSG Capital Advisors, LLC and Carmel Capital Partners, LLC. The multiple roles and additional compensation received create conflicts of interest, mainly due to the fact that these other obligations take time away from his duties performed for TIH. To help mitigate the conflicts, TIH has implemented certain controls, including supervisory procedures to oversee and monitor the services provided by Mr. Goodstein to TIH clients, in addition to performing periodic due diligence reviews on Mr. Goodstein's outside business activities. Additionally, the conflicts surrounding the outside business activities and additional compensation are disclosed to clients at the time of entering into an advisory agreement, mainly through the delivery of the TIH Disclosure Brochure (ADV Part 2A) and this Supplement Brochure.

Item 5: Additional Compensation

Other than incentive compensation paid by The Investment House LLC, Glenn Steven Goodstein does not receive any economic benefit from any person, company, or organization, in exchange for providing clients advisory services through The Investment House LLC. As described in Item 4 above, Mr. Goodstein is an investment adviser representative for GSG Capital Advisors, LLC and Carmel Capital Partners, LLC and as such receives compensation from both firms. This compensation accounts for approximately 90% of Mr. Goodstein's annual income.
