Allison Kaylor Flink is licensed to sell life insurance products; she sells insurance products through NFP Advisor Services, LLC and spends approximately 20 hours per month in this role. Allison is also separately

licensed as a Registered Representative of NFP Advisor Services LLC, a FINRA member broker dealer, and an investment adviser representative of NFP Retirement, a SEC registered investment adviser. She spends approximately 100 hours per month in this role. Allison may effect securities transactions and sell related investment products for clients, for which she receives separate, yet customary compensation. While Allison endeavors at all times to put the interests of the clients first as part of her fiduciary duty, clients should be aware that the receipt of additional compensation for outside, related activities itself creates an inherent conflict of interest, which may unknowingly affect the judgment of these individuals when making recommendations. Any compensation received from commissions, however, is used to offset any advisory fee charged to the client.

Allison may recommend insurance products and may also, as an independent insurance agent, sell those recommended insurance products to Clients. When such recommendations or sales are made, a conflict of interest exists as the Insurance licensed Investment Adviser Rep earns insurance commissions for the sale of those products, which may create an incentive to recommend such products. We require that all Investment Adviser Reps disclose this conflict of interest when such recommendations are made. Also, we require Investment Adviser Reps to disclose that Clients may purchase recommended insurance products from other insurance agents not affiliated with us.

Allison is a Founding Lecturer for TRAU (The Retirement Advisers University) focused on consulting and compliance for qualified plans for UCLA.
