Item 4 – Advisory Business

GREYTOWN is a newly constituted investment advisory firm, which was incorporated in December of 2012.

As of December 31st, 2013, GREYTOWN managed US\$290.5 million on a discretionary basis and non-discretionary basis. Of the total assets under management, \$71.8 million come from a sub-advisory contract to manage 3rd Party Offshore mutual funds.

Investment Supervisory Services

GREYTOWN provides investment advisory services for off-shore long only mutual funds, financial consulting and individual investment accounts. GREYTOWN provides continual advice to a client regarding investment of client funds based on the individual needs and risk parameters of each client. Through personal discussions in which goals and objectives based on a client's particular circumstances are established, GREYTOWN develops a client's personal profile and creates and manages a portfolio based on that profile. GREYTOWN will manage advisory accounts on a discretionary or non discretionary basis. Account supervision is guided by the stated objectives of the client.

A client financial profile is developed to determine appropriate investments, investment time-frames, and levels of risk. The profile is developed as follows:

1. Gather client information.
2. Consult with client to determine goals and objectives.
3. Review basic financial data which may include overviews of assets and liabilities, cash flow, tax situation, short-term events, long-term goals, risk management, and estate structures.

Managed portfolio services are fee-based and clients are engaged under a specific contract for services. It is common practice in our agreements that either party may terminate their agreement at any time, upon (30) days after receipt of written notice to the other party. If Client terminates the Agreement, Advisor will be entitled to receive the proportionate part of the fee that has earned but not been collected. Until paid, the Advisor's fees shall constitute a lien upon the assets of the Account.

The termination of an Advisory Agreement shall not affect any obligation or liability of the Client for any transaction entered into or obligation incurred by Client, or on Client's behalf, prior to such termination.

The firm provides institutional advisory services to financial institutions in the area of asset allocation and investment product analysis. This service will include weekly calls with management to discuss market trends, new developments and products available, and the investment climate.

We also provide advice and support services to family corporate governance and investment company structures, reviewing their trust and investment companies, and assisting them in dealings with trustees and legal advisors.

Item 5 – Fees and Compensation

Investment Supervisory Services

GREYTOWN offers investment advisory services for a percentage of assets under management, as well as fixed fees. Fees range from 0.375% to 1.5% of assets under management, to be negotiated depending on portfolio size, investment objectives, strategy employed, and whether our involvement is actively managing assets or simply passive reporting of holdings.

The fees are in general paid on a quarterly basis, after service has been rendered, at the beginning of each quarterly cycle based upon the value (market value or fair market value in the absence of market value), of the client's account at the end of the previous quarter. Certain advisory contracts involve payments on a month-end basis.

Greytown may charge flat monthly retainer fees or project fees for non-financial advisory services rendered involving consulting and assistance to family corporate governance and assisting them with their Private Investment Companies and Trusts.

Item 6 – Performance-Based Fees and Side-By-Side Management

GREYTOWN does not charge any performance-based fees (fees based on a share of capital gains on or capital appreciation of the assets of a client). All fees are calculated as described above and are not charged on the basis of income or capital gains or capital appreciation of the funds or any portion of the funds of an advisory client.

Item 7 – Types of Clients

GREYTOWN provides Investment Advisory Services for high net worth individuals, financial institutions, trusts, and private university endowment funds.

We serve clients looking to give us Global Asset Allocation advisory mandates. Institutional clients can also hire us on a consultancy basis, where we provide asset allocation strategies for financial institutions.

We also serve institutional clients looking for our specific expertise in managing Emerging Market Fixed Income strategies. We currently act as advisors and sub-advisors to emerging market fixed income portfolios.

GREYTOWN, as a general rule, requires a minimum dollar value of investible assets of US\$2 million when providing investment advisory services per client. We target family groups with investible assets in excess of US\$5 million.

Item 8 – Methods of Analysis, Investment Strategies and Risk of Loss

GREYTOWN's security analysis methods include fundamental, technical, and global macro analysis. The main sources of information GREYTOWN uses are credit reports from credit agencies, third party research reports, prospectuses, annual reports, filings with the Securities and Exchange Commission (SEC), and Bloomberg analytical tools. The investment strategies used to implement any investment advice given to clients include long term purchases (securities held at least one year), short term purchases (securities sold within one year), and tactical strategies (securities purchased and sold within 30 to 90 days).

In the implementation of investment plans, GREYTOWN may utilize equity and fixed income investments, options, derivatives, mutual funds, hedge funds, and commodities. .

Clients may hold or retain other types of assets as well, and GREYTOWN may offer advice regarding those various asset-classes as part of its services.

GREYTOWN's strategies do not utilize a high concentration in securities that we believe would be classified as having any unusual risks and we do not recommend frequent trading, which can increase brokerage and other transaction costs and have additional tax implications.

Analysis of a Client's Financial Situation

In the development of investment plans for clients, including the recommendation of an appropriate asset allocation, GREYTOWN relies on an analysis of the client's financial objectives, current and estimated future resources, and tolerance for risk. To derive a recommended asset allocation, GREYTOWN may use standard statistical approach for managing portfolio risk. As with any method used to make projections into the future, there are several risks associated with these types of analysis, which may result in the client not being able to achieve their financial goals.

They include:

- The risk that expected future cash flows will not match those used in the analysis methodology
- The risk that future rates of return will fall short of the estimates used in the simulation
- The risk that inflation will exceed the estimates used in the simulation

- For taxable clients, the risk that tax rates will be higher than was assumed in the analysis

Risk of Loss

Investing in securities involves risk of loss that clients should be prepared to bear.

All investments present the risk of loss of principal – the risk that the value of securities or investment products when sold or otherwise disposed of, may be less than the price paid for. Even when the value of the securities when sold is greater than the price paid, there is the risk that the appreciation will be less than inflation. In other words, the purchasing power of the proceeds may be less than the purchasing power of the original investment.

The mutual funds and ETFs utilized by GREYTOWN may include funds invested in domestic and international equities, including real estate investment trusts (REITs), corporate and government fixed income securities and commodities. Equity securities may include large capitalization, medium capitalization and small capitalization stocks. Mutual funds and ETF shares invested in fixed income securities are subject to the same interest rate, inflation and credit risks associated with the underlying bond holdings.

Among the riskiest asset classes used in GREYTOWN's investment strategies funds are the U.S. and International small capitalization equities, emerging market equities, and commodity futures funds. Conservative fixed income securities have lower risk of loss of principal, but most bonds (with the exception of Treasury Inflation Protected Securities or TIPS) present the risk of loss of purchasing power through lower expected return. This risk is greatest for longer-term bonds.

More information about the risks of any particular market sector can be reviewed in representative prospectuses for each applicable investment, when available.

Types of Investments

GREYTOWN offers advice on exchange-listed securities, corporate debt securities, commercial paper, United States government securities, option contracts on securities, and interests in private equity, partnerships investing in real estate, commodities, mutual funds and hedge funds.

Item 9 – Disciplinary Information

Registered investment advisors are required to disclose all material facts regarding any legal or disciplinary events that would be material to your evaluation of GREYTOWN or the integrity of GREYTOWN's management. GREYTOWN has no information applicable to this Item.

Item 10 – Other Financial Industry Activities and Affiliations

GREYTOWN is affiliated with BAC Florida Bank, a Florida based bank, BAC Florida Investments, an SEC registered broker dealer, and BAC Global Advisors, an investment advisor, by means of common control.

GREYTOWN's IAR's may also be dually licensed as registered representatives of BAC Florida Investments (BFI), an affiliate of GREYTOWN. Such IARs, when acting in their capacity of registered representatives of BFI, may **not** earn commissions for effecting securities transactions through BFI. However, fees paid to GREYTOWN for advisory services are separate and distinct from the fees charged and commissions earned for services provided through BFI. Clients to whom the Firm offers advisory services are informed that they are under no obligation to use BFI or its representatives for their broker dealer services and may use the service provider of their choosing.

Item 11 – Code of Ethics

GREYTOWN has adopted a Code of Ethics expressing the firm's commitment to ethical conduct. GREYTOWN's Code of Ethics describes the firm's fiduciary duties and responsibilities to clients and sets forth GREYTOWN's practice of supervising the personal securities transactions of employees with access to client information. Individuals associated with GREYTOWN may buy or sell securities for their personal accounts identical or different than those recommended to clients. It is the expressed policy of GREYTOWN that no person employed by the firm shall prefer his or her own interest to that of an advisory client or make personal investment decisions based on investment decisions of advisory clients.

To supervise compliance with its Code of Ethics, GREYTOWN requires that anyone associated with this advisory practice with access to advisory recommendations provide annual securities holding reports and quarterly transaction reports to the firm's Chief Compliance Officer. GREYTOWN also requires such access persons to receive approval from the Chief Compliance Officer prior to investing in any IPO's or private placements (limited offerings).

GREYTOWN requires that all individuals must act in accordance with all applicable Federal and State regulations governing registered investment advisory practices. Any individual not in observance of the above may be subject to discipline.

GREYTOWN will provide a complete copy of its Code of Ethics to any client or prospective client upon request.

Item 12 – Brokerage Practices

GREYTOWN's clients utilize BAC Florida Investments (BFI) as their preferred broker dealer, but GREYTOWN does not have an exclusive arrangement with BFI and may recommend other broker dealers when appropriate. BFI is an affiliate of GREYTOWN by common control.

However, when clients direct brokerage:

- GREYTOWN may be unable to achieve best execution of clients' transactions, and this may cost clients more money in brokerage commissions, fees, and other charges.
- GREYTOWN will not have authority to negotiate commissions among various brokers or obtain volume discounts.
- A disparity in commission charges may exist between the commissions charged among clients.

BFI performs its securities custody, clearing, and settlement through Pershing LLC., a subsidiary of The Bank of New York Mellon Corporation. BFI is a member of FINRA (Financial Industry Regulatory Authority and formerly known as NASD). BFI is also regulated and supervised by the Securities and Exchange Commission (SEC).

To the extent that GREYTOWN puts in orders on behalf of clients, these trades will be executed according to the practices of the brokerage firm where clients hold accounts.

GREYTOWN generally does not aggregate any client transactions in mutual fund or other securities. Client accounts are individually reviewed and managed, and transaction costs are not saved by aggregating orders in most circumstances in which GREYTOWN arranges transactions.

Item 13 – Review of Accounts

Investment Supervisory Services

Reviews:

Performance and Portfolio Reviews are conducted monthly with Strategy Reviews performed quarterly. The reviewer is Marcello Correa, President and Chief Executive Officer, together with Luis Antonio Samayoa, our CFO.

We may review a clients' portfolio at any time if there is a change in risk profile for the client.

Reports:

Unless otherwise agreed upon, clients are provided with transaction confirmation notices and regular summary account statements directly from the broker-dealer or custodian for the client accounts. Those clients to whom GREYTOWN provides investment advisory services will also receive a report from their custodian that may include such relevant account and/or market-related information such as an inventory of account holdings and account performance as clients may request from time to time.

In addition, clients receive either monthly or quarterly Performance and Portfolio Reports on their accounts prepared by GREYTOWN.

Item 14 – Client Referrals and Other Compensation

GREYTOWN does not have any arrangements, oral or in writing, where it is paid cash by or receives some economic benefit (including commissions, equipment or non-research services) from a non-client in connection with giving advice to clients. It does have

arrangements, in writing, where it directly compensates eligible finders for client referrals. If the client was referred to GREYTOWN by a finder, the “finder” is compensated according to the “finder’s agreement”. The client receives a Disclosure Statement informing him of this compensation to the finder.

GREYTOWN currently only utilizes non-resident finders for non-resident clients.

Item 15 – Custody

Clients should receive at least quarterly statements from the broker dealer, bank or other qualified custodian that holds and maintains client’s investment assets. GREYTOWN urges clients to carefully review such statements and compare such official custodial records to the account statements that we may provide to clients. Our statements may vary from custodial statements based on accounting procedures, reporting dates, or valuation methodologies of certain securities.

Item 16 – Investment Discretion

GREYTOWN may have the authority to determine, without obtaining specific client consent, the securities to be bought or sold, and the amount of securities to be bought or sold, according to the investment strategy put forward on a quarterly basis on discretionary accounts. This is put forth in the Investment Advisory Agreement entered by GREYTOWN and the client. However, it does not have the authority to determine, without obtaining client consent, the broker or dealer to be used, or the commission rates paid to the broker dealer.

Item 17 – Voting Client Securities

As a matter of firm policy and practice, GREYTOWN does not have any authority to, and does not, vote proxies on behalf of advisory clients. Clients retain the responsibility for receiving and voting proxies for any and all securities maintained in client portfolios. Clients will receive applicable proxies directly from the issuer of securities held in clients’ investment portfolios.

Clients will receive applicable proxies directly from the issuer of securities held in clients' investment portfolios.

Item 18 – Financial Information

Registered investment advisors are required in this Item to provide you with certain financial information or disclosures about GREYTOWN's financial condition. GREYTOWN has no financial commitment that impairs its ability to meet contractual and fiduciary commitments to clients, and has not been the subject of a bankruptcy proceeding. GREYTOWN does not charge clients for advisory services in advance.
