Item 3: Disciplinary Information

Mr. Harris was involved in a costumer dispute during his time at UBS Financial Services, Inc. ("UBS"). The plaintiff alleged breach of fiduciary duty, negligence, amongst other allegations. UBS settled with the costumer in June 2006 in the amount of \$20, 000, none of which was contributed by Mr. Harris.
