There are no legal or disciplinary events that are material to the evaluation of Mr. Zundel.

### **Item 4: Other Business Activities**

---

Mr. Zundel is a licensed insurance agent. He may offer insurance products and receive normal and customary fees as a result of insurance sales. A conflict of interest may arise as these insurance sales may create an incentive to recommend products based on the compensation he and/or our supervised persons may earn.

Mr. Zundel is the Managing Partner of Zundel Holdings, LLC; Member of the Board of Directors for Redsky Solution, LLC; and Manager of JMZ Real Property, LLC. These activities are not investment related and he spends a few hours per month with these activities. Our firm has examined these activities for potential conflicts of interest and has determined that these outside business activities do not deter from the quality of his management services.

Mr. Zundel invests in private equity opportunities, such as Truck Shields, LLC, Turning Point Retail Corporation, Redsky Solutions, and PD-UT Investments, LLC, that make up at least 10% of his total income, which is paid directly from the investment. Participation in this activity may result in co-investing with advisory clients. This presents a potential conflict of interest. To mitigate this conflict Mr. Zundel discloses his participation and compensation to advisory clients who also invest in the same private equity opportunity. Mr. Zundel neither receives referral fees, management fees, or carried interest from these investments nor does he solicit these investments to advisory clients.

### **Item 5: Additional Compensation**

Mr. Zundel does not receive any additional compensation or economic benefit outside of his regular salary such as any sales awards or other prizes for providing advisory services or selecting a particular investment.

### **Item 6: Supervision**

---

Mr. Zundel is the sole principal and Chief Compliance Officer and as such has no internal supervision placed over him. He is, however, bound by our firm's Code of Ethics.

### **Item 7: Requirements for State-Registered Advisers**

Mr. Zundel has not been involved in any arbitration claim alleging damages in excess of \$2,500. Furthermore, he has neither been involved in nor found liable in any civil, self-regulatory organization, or administrative proceeding nor has been the subject of any bankruptcy petitions.
